OISM-Petition zur globalen Erwärmung (<http://www.oism.org/pproject/>)

Überschrift und Zusammenfassung der Petition:

Wir fordern die Regierung der Vereinigten Staaten dringend auf, das im Dezember 1997 in Kyoto (Japan) geschriebene Abkommen über die globale Erwärmung und andere ähnliche Vorschläge abzulehnen. Die vorgeschlagenen Grenzwerte für Treibhausgase würden die Umwelt schädigen, den Fortschritt von Wissenschaft und Technologie behindern und die Gesundheit und das Wohlergehen der Menschheit beeinträchtigen.

Es gibt keine überzeugenden wissenschaftlichen Beweise dafür, dass die Freisetzung von Kohlendioxid, Methan oder anderen Treibhausgasen durch den Menschen in absehbarer Zeit eine katastrophale Erwärmung der Erdatmosphäre und eine Störung des Erdklimas verursacht. Darüber hinaus gibt es erhebliche wissenschaftliche Beweise dafür, dass ein Anstieg des atmosphärischen Kohlendioxids viele positive Auswirkungen auf die natürlichen Pflanzen- und Tierumgebungen der Erde hat.

We urge the United States government to reject the global warming agreement that was written in Kyoto, Japan in December, 1997, and any other similar proposals. The proposed limits on greenhouse gases would harm the environment, hinder the advance of science and technology, and damage the health and welfare of mankind.

There is no convincing scientific evidence that human release of carbon dioxide, methane, or other greenhouse gasses is causing or will, in the foreseeable future, cause catastrophic heating of the Earth's atmosphere and disruption of the Earth's climate. Moreover, there is substantial scientific evidence that increases in atmospheric carbon dioxide produce many beneficial effects upon the natural plant and animal environments of the Earth.

Letter from Frederick Seitz

Research Review of Global Warming Evidence

Enclosed is a twelve-page review of information on the subject of "global warming," a petition in the form of a reply card, and a return envelope. Please consider these materials carefully.

The United States is very close to adopting an international agreement that would ration the use of energy and of technologies that depend upon coal, oil, and natural gas and some other organic compounds.

This treaty is, in our opinion, based upon flawed ideas. Research data on climate change do not show that human use of hydrocarbons is harmful. To the contrary, there is good evidence that increased atmospheric carbon dioxide is environmentally helpful.

Environmental Effects of Increased Atmospheric Carbon Dioxide

A review of the research literature concerning the environmental consequences of increased levels of atmospheric carbon dioxide leads to the conclusion that increases during the 20th Century have produced no deleterious effects upon global weather, climate, or temperature. Increased carbon dioxide has, however, markedly increased plant growth rates. Predictions of harmful climatic effects due to future increases in minor greenhouse gases like CO₂ are in error and do not conform to current experimental knowledge.
